

- 1. All lifters must have a qualifying total dating back to one calender year, including the state meet of 1995 and a full time high school student of Wisconsin.
- 2. A clean T-shirt with sleeves no pockets or designs other than generic powerlifting or your high school logo. Gym shorts ,biking short thigh length, wrestling singlet or power suit.

3. One piece lifting suit is highly recommended

4. No baby power, Bench Shirt, or Ammonia

5. ADFPA cards-This is a ADFPA sanctioned meet. Card cost is included in the entry fee. All lifters must be **drug free** for at least 36 months. All lifters must willfully subject themselves to **drug testing** as required. Failure to do so will result in immediate disqualification from the meet, along with forfeit of any awards earned.
